Why the Standard Contractual Clauses Must be Implemented Immediately

Privacy Shield is Invalid

If you (or your customers) relied on Privacy Shield as the mechanism to legally transfer personal data from the EU to the US, it is no longer valid.

No Grace Period

Ongoing transfers are illegal until an alternative mechanism is implemented.

Liability is shared between the exporter (i.e. the customer) and the importer (you).

Sole Alternative

The sole alternative is to implement a contractual framework approved in the EU called the Standard Contractual Clauses aka the SCC.

Lawsuits Already Pending

There are 101 lawsuits already pending against companies who have failed to implement the SCC and are continuing to rely on Privacy Shield.

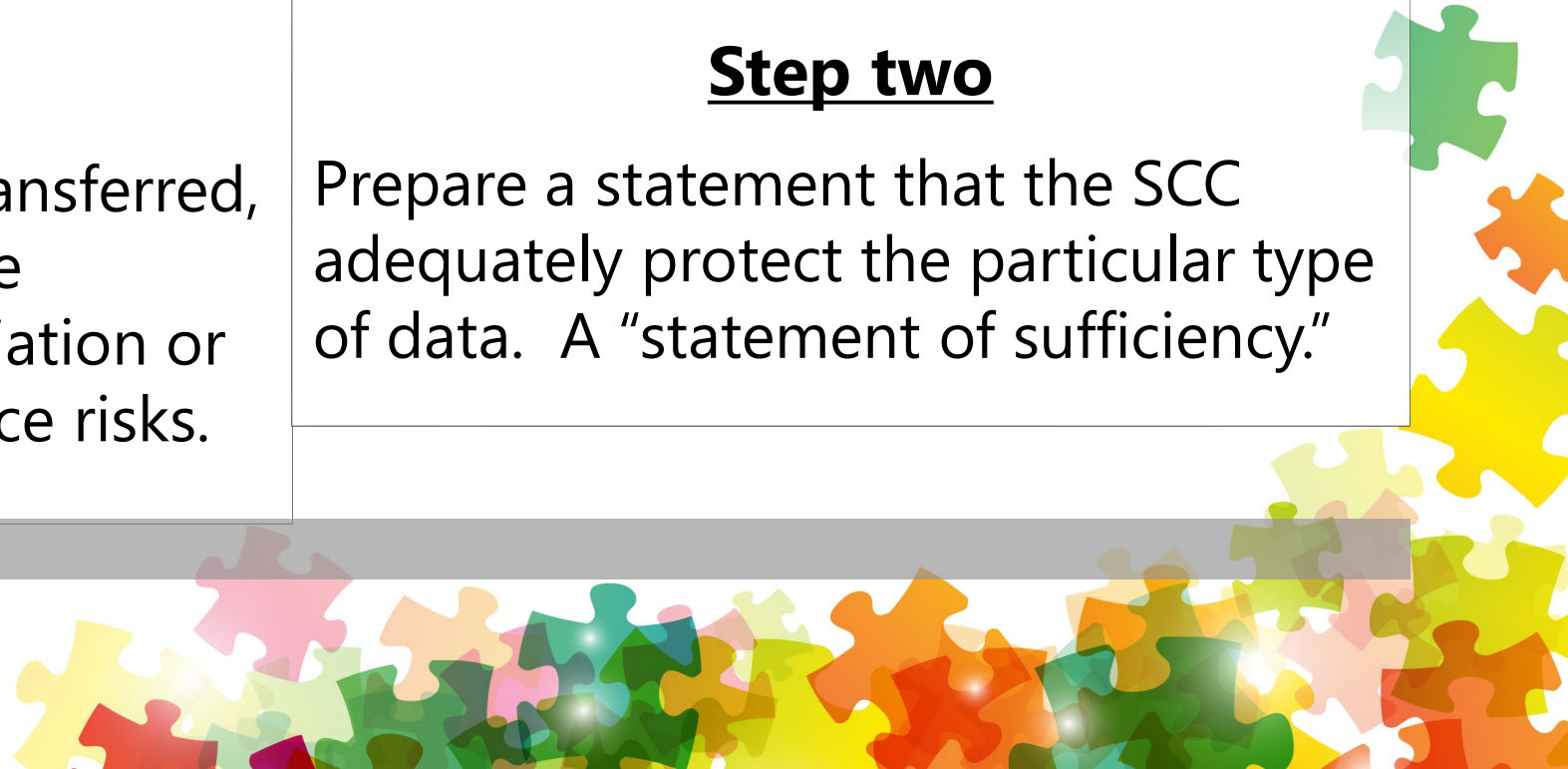
Getting you in the Right Position
